

TERMS OF SERVICE

Pladey

Effective Date: April 30, 2026

Please read these Terms of Service ("Terms") carefully before using the Pladey mobile application ("App", "Service") operated by Pladey ("we", "us", "our"). By downloading, accessing, or using the App, you agree to be bound by these Terms. If you do not agree, do not use the App.

1. Eligibility

You must be at least 13 years of age to use Pladey. By using the App, you represent and warrant that you meet this requirement. If you are between 13 and 18 years of age, you must have parental or guardian consent to use the App.

2. Account Registration

To access certain features of the App, you must create an account. You agree to:

- Provide accurate, current, and complete information during registration
- Maintain and promptly update your account information
- Keep your password secure and confidential
- Notify us immediately of any unauthorized use of your account
- Accept responsibility for all activities that occur under your account

We reserve the right to suspend or terminate your account if any information provided is found to be inaccurate, false, or incomplete.

3. Use of the App

3.1 Permitted Use

14. Governing Law

These Terms shall be governed by and construed in accordance with applicable laws, without regard to conflict of law principles. Any disputes arising under these Terms shall be subject to the exclusive jurisdiction of the competent courts.

15. Severability

If any provision of these Terms is found to be invalid or unenforceable, that provision will be limited or eliminated to the minimum extent necessary, and the remaining provisions will remain in full force and effect.

16. Entire Agreement
